



AWLFC Rules and Waiver Of Liability For Vendors

1. No water will be supplied, except drinking water made available to dogs and non-alcoholic beverages for purchase by Liganore Winecellars-Berrywine Plantations.
2. Booths/displays may not be dismantled or goods removed before 4:00 PM.
3. A permit is required from Frederick County Department of Health and Human Services if food items will be prepared, sold, or given away. (This includes a current copy of your food service license as well as a certificate of insurance). AWLFC and Liganore Winecellars-Berrywine Plantations will not be responsible for obtaining or paying for any required permits.
4. Beverages, including water or soda may not be offered for sale.
5. The AWLFC or "K-9 in the Vines" logos may not be used for any purpose without expressed written permission of AWLFC.
6. The State of Maryland requires any person selling used or new products to charge 6% sales tax and have a Maryland Tax number. If a temporary Maryland sales tax license number is needed, one can be obtained by calling the comptroller of Maryland at 1-888-615-0369. License is good for 30 days and there is no fee.

Neither AWLFC nor Liganore Winecellars-Berrywine Plantations will be held liable for any damages, whether direct, indirect, general, special, consequential, or other wise to the vendor, its products, or exhibits, its agents, or employees or visitors, it's exhibits whether occasioned by AWLFC and Liganore Winecellars-Berrywine Plantations, or either of their agents, volunteers or employees, or by another Vendor, and it's agents and employees.

I understand that any violations of any part of this agreement shall, at the election of the AWLFC and/or Liganore Winecellars-Berrywine Plantations, result in the revocation and forfeiture of all rights and privileges, present and/or future, granted by the AWLFC and Liganore Winecellars-Berrywine Plantations to the vendor, and in the event of such breach by the vendor and the election by the AWLFC and Liganore Winecellars-Berrywine Plantations, all sums paid by the vendor to AWLFC shall be forfeited to the AWLFC as liquidated damages. I understand that I will not hold the AWLFC and/or Liganore Winecellars-Berrywine Plantations responsible if I do not make profit. I am responsible for providing all items necessary for my booth operations. I hereby release AWLFC
